

**TREMBLANT VOLUNTEER
ACCEPTANCE OF RISKS AND INDEMNIFICATION AGREEMENT**
Valid from May 1st, 2023 to April 30, 2024

Definitions of terms for the present contract:

- a. The expression "volunteer" means any person who offers his/her services without remuneration for a period of less than 18 days during the above-mentioned period;
- b. The expression "activity" means any act performed by a volunteer for Mont Tremblant Resorts and Company, Limited Partnership;
- c. The expression "organization" means Mont Tremblant Resorts and Company, Limited Partnership.

ACCEPTANCE OF RISKS:

I fully understand that through the practice of the activities, it is possible that I will expose myself to the inherent risks of the said activities.

I ACCEPT IN GOOD FAITH AND FULLY ASSUME THE POSSIBLE RISKS, INCLUDING THE POSSIBILITY OF BODILY INJURY, DEATH, DAMAGES AND LOSSES OF PROPERTY THAT MAY OCCUR AS A RESULT.

RELEASE OF RESPONSIBILITY, DISCHARGE, AND INDEMNIFICATION AGREEMENT:

Given that Mont Tremblant Resort and Company, Limited Partnership has agreed to allow me to participate in the activities and has authorised me to use the lifts, trails, restaurants, parking lots and other installations which it owns, I therefore agree to the following conditions:

1. **TO RENOUNCE ALL CLAIMS against MONT TREMBLANT RESORT AND COMPANY, LIMITED PARTNERSHIP, Station Mont Tremblant Inc., Alterra Mountain Company and all their subsidiaries, as well as their employees, administrators, directors and their insurers regarding my role and status of volunteer;**
2. **I acknowledge that as volunteer for the organization, I am not eligible for any worker's compensation indemnity related to personal injury and any other related expenses;**
3. **I also acknowledge that as volunteer for the organization, I am not eligible to any of the organization's insurance coverage for property damage and/or pecuniary losses. Moreover, no personal injury insurance coverage is provided by the organization ;**
4. **The present contract is executory and binds my assignees, subrogates, heirs, next of kin, executors and personal representatives;**
5. **The present contract will be governed and interpreted in conformity to the existing laws in the province of Quebec. All litigation between the parties must be introduced before a tribunal in the province of Quebec. The volunteer agrees to elect domicile in the judicial district of province of Quebec and declare that same is the appropriate forum for any and all claims, of whatever nature, arising from this contract.**

I ATTEST HAVING READ AND UNDERSTOOD THE CONDITIONS OF THE PRESENT CONTRACT AND KNOW THAT BY SIGNING I RENOUNCE TO EXERCISE SOME RIGHTS THAT OTHERWISE I OR MY ASSIGNEES, SUBROGATES, HEIRS, NEXT OF KIN, EXECUTORS AND PERSONAL REPRESENTATIVES MIGHT HAVE AGAINST THE ORGANIZATION.

Participants under 18 years of age must have their parents or legal guardian's written consent to participate in the activities.
